Bo Holland is a veteran entrepreneur who has been delivering innovative technology solutions to financial institutions for over twenty years. In 2004, Holland founded AllClear ID, formerly Debix, and currently serves as CEO. Holland holds the patent for Instant Authorization technology, the basis for the exclusive AllClear Credit Monitoring (U.S. Patent No. 7,983,979).

Holland was previously founder and CEO of Works, Inc., which was acquired by Bank of America in 2005. Holland invented the patent-pending technology that enables large organizations to approve and control payments for operating expenses via credit cards.

Prior to Works, Holland served as Director Product and Marketing for Pervasive Software. He was instrumental in turning the company around and taking it public in September 1997. Prior to Pervasive, Holland joined Citrix Systems as employee 32 and was the key figure in developing the product strategy and distribution that laid the foundation for the company revenue growth to over \$750 million in 2004.
