KEY FINDINGS: D&O

- Total filings and enforcement actions down 41 percent from previous quarter largest decline since before financial meltdown
- On pace for lowest annual total since 2006
- The number of securities fraud cases fell 59 percent from the previous quarter
- Breach of fiduciary duties was the leading type of new securities filing in Q2
- Continued decline in new merger objection suit filings
- SCA suits filings ticked higher both number and percentage of total
- Financial services sector remained leading source of new filings
- Number of SCA settlements up, but average value down






KEY FINDINGS: CYBER AND D&O

- Federal and state governments are taking increasingly active role in addressing private sector cyber issues
- Corporate leaders will be increasingly held accountable by both shareholders and regulators
- Emerging cyber related D&O exposures include:
 - Expanded cybersecurity disclosure obligations
 - FTC "Red Flag Rule"
 - Increased network security compliance obligations
 - Heightened involvement by government agencies and law enforcement authorities



SUITS BY TYPE



MERGER OBJECTION CASES ANNUALIZED




