

Securities Litigation – 2009 Review

Overview

- Securities cases = 910 filings, 804 in 2009.
- Madoff- and credit crisis- 400
 related flood first half, 200
 fell off second half. 0
- Financial firms led (38%), but more disperse by Q4 (26%).






Case Breakdown – 2009 Review

Of the 907 Securities Suits


- 340 securities fraud (37%).
- 234 SCAS (26%).
- 216 breach of fiduciary duties (24%).
- 65 derivatives action (7%).
- 55 Ponzi schemes, collective action, others (6%).





Jurisdiction – Q4 2009


Major Filing Jurisdictions - Q4 2009





Sector Impact Metric[™]




Market Cap Impact Metric™






Market Cap Impact Metric[™]

Credit Crisis-Related Cases






Globalization of Securities Litigation






Average Settlement/Awards

- SCAS Q4 = \$43 million







Credit Crisis and Madoff


Credit crisis all-time securities suits breakdown:

- 342 suits, 2 in Q4 2009
- 60% SCAS
- 15% derivative actions
- 13% securities fraud Types of Credit Crisis Securities Suits



Madoff all-time securities suits breakdown:

- 119 suits, 7 in Q4 2009
- 39% fiduciary duties
- 20% collective action


